Application forms should be submitted by the competent authorities – in the foreign country or company wishing to participate – to PEIFE.

These participations will be in any of the following:

- c Sale Hall.

Payable fees and rentals of this category should be settled in foreign currency according to

non - resident currency regulation.

2- Syrian participants:

Application forms should be submitted directly by the sector wishing for participating to PEIFE.

These participations will be in any of the following:

- Syrian Pavilion.
- Sale Hall.
- Independent Exhibition Pavilions.

Payable fees and rentals of this category should be settled in Syrian Pounds.

N.B:

- All the participants have been permitted to put their exhibits during the fair for local consumption directly according to the rules and regulations in force .
- Deadline for receiving application forms with relevant documents is 13 / 6 / 2011 .
- Application forms received after that date might be considered within the available limits then.
- Minimum of reserved space is 12 m² either indoor or outdoor space.
- Minimum of reserved space for exhibiting heavy machinery is 50 m²
